## The State of FGCU

**Steve McIntosh** introduced our speaker, **Steve Magiera**, Vice President of Administration at FGCU. Steve Magiera is from Indiana, an IU grad, and a CPA. McIntosh says, "He is a guy you never see, who makes the budgets work, gets to Tallahassee to work with legislators, and who is responsible for all hiring except academic positions."

FGCU opened in 1997. Hiring of staff started in 1993, Steve was hired in 1995. The first class, in 1997, had 2,500 students, including 200-300 freshman. The upperclassmen were from a USF campus that was closed. The first graduating class was in 1997 and the graduates were allowed to have either a USF or FGCU diploma.

Today there 14,500 students on campus, 80 buildings, with 4,700 live-in students. Student housing now is quite different as students demand their own bedroom, a far cry from the dormitories of yesteryear.

FGCU offers 51 undergraduate programs, 31 graduate programs, and doctoral programs in Physical Therapy and Education.

The University's growth has changed in the last couple of years. It had been growing at 9-10% per year but now is 2-2 1/2%. The State's funding model no longer emphasizes increasing enrollment and has resulted in FGCU concentrating on selecting better prepared students. Incoming student average SAT's have increased from 1529 2 years ago to as high as 1667 for this year's selections.

For Bob, "At age 85, God is not finished with me yet and I feel called to serve specifically in the name of Jesus Christ." Bob is going to serve in other organizations.

Sandy said, "We are a more diverse club now than eight years ago when I joined. Although we are predominately Christian, the Christians within the club have very different viewpoints. We have atheists,

agnostics, and other religions, a variety of viewpoints. The Board made the decision to use the Rotary Prayer Book because we wanted to be welcoming to everyone. We wanted everyone to feel it was their club, and not specific to a particular religion."

**Susan Hill** is leading the club's effort for **Walk for Water**. The Walk will be Saturday, February 23rd, 9-11 am at the YMCA. This is a joint effort of our club, the Noon club, and the Estero club to raise money for a clean water project in Guatemala.

To participate the cost is \$20 for a family or \$10 for an individual. Encourage your friends, neighbors, and visitors to participate and support this outreach project for clean water.

## Florida Bar Association Recognizes Greg Holtz

The Florida Bar Association **recognized 21 lawyers for their work on behalf of poor and indigent clients** at a January 29th ceremony at the Supreme Court of Florida.

Established in 1981, The Florida Bar President's Pro Bono Service Awards are **intended to encourage lawyers to volunteer free legal services to the poor by recognizing those who make public service commitments** and to raise public awareness of the substantial volunteer services provided by Florida lawyers to those who cannot afford legal fees.

**Greg Holtz was the recipient for the 20th Judicial Circuit** (Charlotte, Collier, Glades, Hendry and Lee counties).

The Citation:

“After earning his law degree in 1977 from Case Western Reserve University, Gregory T. Holtz was a legal counsel for the United Savings Association in Cleveland, then was a prosecutor and solicitor for Brooklyn Heights, Ohio, and also ran his own firm for five years.

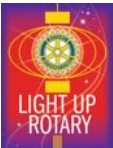
“He was admitted to The Florida Bar in 1980. But in 1984, he went into the banking industry, eventually becoming senior vice president and managing director of U.S. Bank in Naples.

“After all those years in the banking industry, **Holtz had a strong desire to use his skills to help people who were less fortunate.** So he approached Legal Aid Service of Collier County, offering his services as a pro bono attorney. **Since**

**mid-2013, Holtz has handled more than 30 pro bono cases and provided more than 190 hours of pro bono service** for Legal Aid Service of Collier County and the Collier Lawyers Care Pro Bono Program.

“Holtz also is a professor at Ave Maria School of Law in Naples. There, in addition to being an instructor in wills, trusts and estates, **he supervises externships and a pro bono program, allowing law students to assist in the delivery of legal services to the underserved.**”
