

Last Week Program

Marjorie Rubacky introduced our guest speaker **Chris Patricca**, Lee County school board member representing District 3.



Chris is married has 3 kids and an RYE student in Lee County Schools. She is an Adjunct Professor, teaching Justice Studies classes, at Florida Gulf Coast University. She has been a frequent volunteer in the School District, in the classrooms and serves on several Committees. Chris says, "My involvement in the District made me realize how many good things happen in our schools every single day. My experiences as a mother, attorney, teacher, and volunteer have created a desire to do more for the education of all of the students in Lee County".

She treated us to an overview of the Lee County School system: **More than 90,000** students, **120 schools**, \$1.5bn budget. The Vision 2020 goals include increasing student achievement, increase family and community engagement, increase retention of effective and highly effective employees, and become a model continuous improvement organization.

At present, the system needs \$400 million for construction and reconstruction of schools needed to house the existing and projected students. The state department of education has agreed to the forecasted need. The school board is working on ways to fund these projects.

She told us that Lee County's middle and high schools offer a diverse collection of Career & Technical Education programs to prepare students for college and career readiness. Over 4,600 certifications were earned in the 2016-17 school year.

As a college student, Chris had a waitress job for two years at a restaurant that hosted a Rotary Club. On her last day working there, the members passed a bucket and gave her enough money to pay for her books in her first year in law school.


Darrell Haney is an Ohio resident who came down with his chainsaw to help. Wayne Hemstead


