He served as CEO of several successful companies and led a not-for-profit company that promoted a smoking cessation program for teenagers. Rotary Peace Centers Shape Peace and Conflict Resolution

With bloody conflicts raging in the Middle East, Eastern Europe, and parts of Central Africa, the message of nonviolence and reconciliation that nations worldwide observed in late September demands more urgent and collective attention.

In 2001 the United Nations designated September 21 as an annual International Day of World Peace "to be observed as a day of global ceasefire and nonviolence" according to a General Assembly resolution.

The day's devotion to peace connects closely with what Rotary members have been fostering since The Rotary Foundation's mission to advance world understanding, goodwill, and peace, was proclaimed in 1917. Rotary's goal of worldwide peace and tolerance has been an unwavering pursuit: conducting global forums, hosting



international peace symposiums, advancing peace through its 60-year collaboration with the UN, as well as grassroots initiatives such as the Rotarian Action Group for Peace.

But Rotary's most significant effort to wage peace is the

Rotary Peace Centers program, established in 2002. Each year, the program trains some of the world's most dedicated and brightest professionals, preparing them to promote national and international cooperation and to resolve conflict. They include graduates of a two-year master's degree program and a three-month professional certificate program at Rotary's partner universities.

Today, more than 900 peace fellows are applying their expertise in various fields. They're settling border conflicts in West Africa, developing aid programs at the World Bank, drafting legislation to protect exploited children in Brazil, providing security for U.S. diplomats, and many other career paths devoted to peace. Club Assembly Effects Good and Positive Change

Last week **President Sandy** convened the Club into Assembly primarily for purposes of proposing and seeking consent to a variety of important changes in our By-Laws. As a result of our deliberations, relevant sections of the By-Laws have been amended to read as follows:



Article I/II (Board of Directors)

Article I: At least 30 days prior to there annual meeting of the Club in December, the President, with consent of the board of directors, shall appoint a represented nominating committee consisting of the President-Elect and four active members of the club who are not presently serving as directors. At three regular meetings of the club prior to the annual meeting, the nominating committee shall actively solicit recommendations from active members to be elected to serve as directors for three year terms. At the meeting of the club, the nominating committee shall present a slate of three (3) active members for election, and the presiding offer shall invite further nomination of active members from the floor. If there are additional nominations from the floor, a written ballot shall be distributed and all three active members who receive the greater number of votes shall be declared elected. If there are no additional nominations from the floor, the three active members presented by the nominating committee shall be declared elected.

Article II: The governing body of this club shall be the board of directors, consisting of thirteen (13) members of this club, namely nine (9) directors elected in accordance with article I, section I of these by-laws, and then the President, President-Elect, Secretary and Immediate Past President.

Article V (Fees and Dues)

Section 2. A club member shall be responsible for the payment of both membership dues and club fees. Membership dues shall consist of Rotary International per capita dues, subscription fees to The Rotarian Magazine, district per capita dues, club annual dues and any other Rotary or district per capita assessment. Said membership dues shall not exceed \$225 per annum. Club fees shall consist of meal costs, and if applicable, a member's sustaining fund contribution. Membership dues and club fees

shall be payable quarterly on the first day of July, October, January, and April.

Article X (Finances)

Section 1. The Treasurer shall deposit all funds in a banking institution to approved by the board. The deposits of said banking institution must be insured by the Federal Deposit Insurance Corporation (FDIC).

Article XII (Termination of Membership)

Section 1. Membership may be terminated by a member's failure to pay quarterly membership dues and club fees as described in article V, section 2 within 90 days of the date inscribed on said invoice.

Section 2. If a member has failed to pay the membership dues and club fees as described in Article V, Section 2 within 30 days, the member will receive a monthly invoice by US Mail until the account is current. If the member has failed to pay the dues and fees within 60 days of the date inscribed on the invoice, the Treasurer shall assess a \$25 late fee to the outstanding balance. If a member has failed to pay the dues and fees as described in Article V, Section 2 within 90 days of the date inscribed on the invoice, the Treasurer shall be responsible for informing the delinquent member and club President by regular US mail and, if applicable, electronic mail. The board shall vote on the termination of membership of the delinquent member at the next scheduled board meeting. Under exceptional circumstances, the board may delay termination of membership for one board meeting on the recommendation of the Treasurer and the written petition of the delinquent member to be delivered through the Treasurer. The Treasurer shall be responsible for informing the delinquent member of the extension to pay past dues and fees. The President shall be responsible for informing the member, should the board vote on termination.
