## MEMBER SPOTLIGHT



On his way to the podium, **Carl Nickel** bid us a cheesy good morning, eulogized former Green Bay Packer coach Vince Lombardi, and gave us greetings from Title Town, USA. After that, it was not hard to believe that he was born and brought up on a dairy farm near Green Bay.

As a middle schooler, he decided he wanted to be a CPA. He graduated from the U of Wisconsin, joined Arthur Young, an international accounting firm, and became a CPA. In 1976, he left AY to become a sole practitioner in Menomonee Falls, WI. Then, in the late 1990's he sold that practice and moved to Bonita Springs. Here he thought he would be semi-retired and just do a few tax returns.

By 2011, he had 350 clients and was working full time. He then arranged to transfer his clients to Weibel, Hennells, and now works there part time.

In his non-business life, Carl has been an elected official of Wisconsin's largest village district, long time president of his local church, and helped to organize two Chambers of Commerce. He served as president of three chambers.

## LAST WEEK SPEAKER



Last week's speaker was **Patrick Hayhurst**, Director of Security for the Lee County School District. Patrick has been leading the charge to add extra School Resource Officers. Now a total of 10 armed deputies patrol all of Lee County's 50 elementary schools. This is part of a larger recommendation that includes equipping all schools with the

latest safety locks to make classrooms more secure.

He reported on efforts to make all schools have "single-entry" points and said that the layouts of some schools make that impractical. In those cases, there is an emphasis on surveillance, and training of staff to be more vigilant. He noted that is not possible to keep a determined intruder out of a building.

Much of Patrick's discussion was about how to avoid identity theft and fraud. He said that much fraud goes unreported because of the fear of embarrassment. Some of the tips he presented were: sign back of credit cards with "Ask for ID"; don't have your home address programmed as "home" on your GPS; have passwords and lockouts on computers, phones, and tablets; and shred anything with your name or address or other personal information before throwing it out.
