Gerri Spaeth introduced Julie Workman, Director of Programs and Community Relations for the Heights Foundation and the Heights Center.

The center is located in the "Children do well when their Harlem Heights neighborhood of Ft. Myers. It is an area with 400 single family homes, 375 multifamily units, and had 1,200 children. The neighborhood is one

of Lee County's five historically lowest-income communities and is classified as a "Severely Distressed" community.

The Heights Foundation works to build strong, self-sufficient families in the Harlem Heights neighborhood. The mission is to support in partnership with Catalyst Kitchen which is a education and wellness, promote family and community development, and provide the culinary arts by operating training kitchens benefits of enrichment and the arts. The foundation is a grassroots, hands-on organization that celebrates the strength and diversity of the community.

The Ft. Myers-South Rotary Club has been a big supporter of the summer camp program. There were 139 children in camp this summer. A reading program is offered in summer. Many of the children are reading 2 years behind grade level. At the end of the season there was a 25% improvement in reading comprehension of the participants.

The most recent program launch was a free medical clinic in cooperation with the Lee County Volunteers in Medicine. There is a need for professional volunteers who will give 4 hours per month to the clinic that serves only people without insurance. Most of the people of the
