Last Week's Program David Van Sleet "Wounded Warrior Softball"



Last week we were honored to hear a program marked by courage, poignancy, and commitment as David Van Sleet visited and briefed us on the activities of the N a t i o n a l

Wounded Warrior Amputee Softball Team.

David is the team's creator, founder, and head coach and has been involved in prosthetics since 1980, specializing in the fabrication and fitting of prostheses for the VA and commercial offices he has owned and operated.

But the real story was "The Team," an inspirational and talented group of veterans and active duty soldiers who have lost limbs post 9/11 while serving their county. The Team's website describes its mission as that of raising "awareness, through exhibition and celebrity softball games, of the sacrifices and resilience of our military, and highlight their ability to rise above any challenge."

David's remarks (and video) underscored the Team's vision of supporting and honoring our soldiers and veterans, their sacrifices, and how "life without a limb is limitless." Thanks David for a profoundly moving presentation.

Foundation Update

Ray Faubion, Trustee Chairman of our Club



Foundation offered a grant report and news of a new initiative. Specifically for the ten months ending April 30, 2012, our Club Foundation made grants to the following organizations or projects: Dictionary Project; Bonita Assistance Office, Literary

Council; Guatemalan Water Project; Spring Creek and Bonita Elementary Schools; Interact "Make A Wish;" Rotary Camp Florida, Rotary Foreign Exchange Stipend; Meals of Hope; TRF-Match Grant, Salvation Army, YMCA, Polio Plus and the Veteran's Memorial.

We also learned of the Foundation's plan to designate a certain amount of corpus to establish a scholarship endowment. The initial goal for such fund will be \$100,000 with a long term goal in excess of \$500,000. Thanks Ray for this comprehensive report.

From Rotary Interntional Rotary's "Urgent Priority"

Despite the dramatic drop in polio cases in the last year, the threat of continued transmission due to funding and immunization gaps has driven the Global Polio Eradication Initiative (GPEI) to launch the Global Polio Emergency Action Plan 2012-13.

The plan aims to boost vaccination coverage in the three remaining polio-endemic countries - Nigeria, Pakistan, and Afghanistan - to levels needed to stop polio transmission. Health ministers meeting at the World Health Assembly in Geneva adopted a resolution on 25 May that declared "the completion"



of polio eradication to be a programmatic emergency for global public health."

Polio eradication activities have resulted in several landmark successes since 2010. India, long regarded as the nation facing the greatest challenges to eradication, was removed from the list of polio-endemic countries by the World Health Organization (WHO) in February. Outbreaks in previously polio-free countries were nearly all stopped.

"We know polio can be eradicated, and our success in India proves it," says Rotary International President Kalyan Banerjee. "It is now a question of political and societal will. Do we choose to deliver a polio-free world to future generations, or do we choose to allow 55 cases this year to turn into 200,000 children paralyzed for life, every single year?"

Since the start of 2012, the GPEI has moved its operations into emergency mode. The U.S. Centers for Disease Control and Prevention (CDC) has activated its Emergency Operations Center, UNICEF has officially activated an Interdivisional Emergency Coordinating Committee operating directly under the deputy executive director, and WHO has moved its polio operations to its Strategic Health Operations Centre.

In March, The Rotary Foundation Trustees reaffirmed that polio eradication is the Foundation's urgent priority. In addition, Rotary senior leaders have launched a series of one-on-one meetings with the heads of state of the polio-endemic countries.
