Last Week's Program Nancy Ross/ Ray Faubion "Foundation Update"



Last week **Nancy Ross** and **Ray Faubion** collaborated on a very useful and informative update on the activity of our Club Foundation. Joined by members of the Foundation's past leadership team, the presentation offered clear insight into our Foundation's operation and mission.

Its overall corpus approximating \$316,000 our Foundation's grant activity was allocated 45% to Local causes, 9% to those Regional and \$6% to International initiatives. The Grant categories were further divided into sever key focus areas, "Peace," "Water," "Disease and Hunger Prevention; "Maternal and Child Health," "Education and Literacy;" "Economic and Community Development," and "Other, most comprised of distributions to Rotary International."

A partial summary of Grant activity in each of the key focus areas is as follows: **Peace:**

Veterans Memorial \$2500; Foreign Exchange Student Support \$1500; Honor Flight \$500. Water: Guatemalan Water Project \$3100; India Water Project Matching grant \$1000. Dis**ease and Hunger Presentation:** Meals of Hope \$5,000 (combined with \$2000 Club contribution); Tornado Disaster Relief \$2250; Bonita Assistance Office \$250. Maternal/Child Health Polio Plus \$2400. Educational and Literacy: Scholarships \$3500; Dictionary Day \$1097; I Like Me, Spring Creek 1600; Literacy Council-Moms and Tots \$3500; WGCU Reading Rainbow \$1000; Teacher Sponsor \$400; Last Egret \$600. Economic and Community Development YMCA \$4000; Salvation Army \$3000: Matching Grant-Poland \$3000; Camp Florida \$900. Other RI Annual Program Funds \$16,000. Nancy also reported that since June of this year the Foundation has provided grant funding in support of the Wheelchair Foundation facilitating a shipment of wheelchairs to Honduras and a Habitat for Humanity matching grant in Poland.

Ray offered an update on the Foundation's education initiative through earmarking funds for a Scholarship endowment fund. Historically, Ray observed that one of the Foundation's initial focus areas was that of providing scholarship funding so it is fitting and appropriate \$100,000 has been set aside for this purpose. In addition the Foundation will continue to supplement the Scholarship endowment with a portion of the funding it receives from the Club. The endowment can also accept gifts from individual donors and any of the Foundation Trustees would be happy to review that possibility.

The Foundation is a special resource of which we should be proud and there are things we can do as Club members to support its mission. The Foundation approved \$59,508 in support of local projects and initiatives last year so be sure to communicate community needs to any Foundation Trustee and thoughtfully consider a personal contribution to Foundation to allow it to continue work which is local, national, and international in focus. Thanks Nancy and Ray for a comprehensive presentation and to our Foundation Trustees for their good and important work.


