

# The Spoke Rotary







Jason Dolle introduced our speaker, Antoine **Patton,** who has an office near Jason, "This guy is really amazing. Came to town, sees a need, started a non-profit, The Photo-Patch Foundation, and has built an amazing network in a short period of time."

Jason said he was able to relate to the program Antoine has developed. When he was growing up Jason had an "uncle" in prison and knows first hand of the difficulties of communicating with the incarcerated.

Antoine grew up in inner city and suburban Buffalo. He identified a large group of kids who are the "invisible victims" of incarcerated parents. There are more than 2.7 million children of in-prison parents in the U.S. The mission of the foundation is to try to prevent children from following in their parents' footsteps. He notes that 50% of the kids in juvenile detention also have a parent incarcerated. . They are trying to break the cycle

He says relationships need communication. Photo-Patch is helping to make sure the children stay in the parent's life. While in prison, parents may be more willing to encourage kids not to get into trouble, "don't make the same mistakes I did."

Many Children who have an incarcerated parent(s) have not spoken, seen or in anyway communicated with their parent(s) in weeks, months and sometimes years. Some of the problems are that prison may be far away, won't allow email or social media access, and the children don't use "snail mail."

Photo Patch asks the children to upload letters and pictures that they would like to send to their parents using technology the kids already know. Photo Patch will print, package, sign, seal and ship the mail for them.

### ...and you, **the Sponsor**!

"Photo Patch reaches out to potential sponsors, asking for a \$5 donation that will go towards a child uploading 20 pictures and a letter. When you opt to pay for a child to send photos and letters to their parent, Photo Patch will do all of the grunt work. It's called teamwork!

"We ensure:

- Quality photos and letters are printed.
- · Photos and letters are placed in prisonappropriate packaging.
- Envelopes have valid shipping and return addresses.
- Envelopes have sufficient amount of postage attached.
- The child's mail is delivered in a timely fashion.
- Children are notified that their mail has been printed, packaged and shipped."
