LAST WEEK SPEAKER



Carl Schwing introduced our speaker **David Grossi** a retired police lieutenant from upstate NY. David has trained over 170,000 federal, state, local, and international law enforcement officers in Firearms and Use of Force training. He is a court certified expert in police procedure and has been retained in over 500 cases as an expert witness.

Our speaker described a case where an FBI agent was charged of murder/manslaughter in his wife's death. Arthur Gonzales was accused of shooting his wife Julie Gonzales four times on April 19, 2013. Gonzales had claimed his wife came at him with a kitchen knife and he fired his 40 caliber pistol in self-defense. The forensic evidence corroborated Arthur's description of the event.

Gonzales was tried three times by the local District Attorney. The first two trials resulted in hung juries with the jurors overwhelmingly, but not unanimously, in favor of acquittal. After the hung juries, the charge was downgraded to voluntary manslaughter. The judge acquitted him after the third trial.

Dave said, "A local Sheriff's Deputy told me that the District Attorney made it his mission to ruin the agent financially and professionally, but he only accomplished one half of his mission. Art was acquitted but did lose his house, job, and pension... That, as some professionals call it, is 'The New Normal' about how our criminal justice system works."

Jim Dati commented "When you think of the number of criminal trials that are



conducted in the U.S. day in and day out, we still have, I think, the finest criminal justice system in the world. We still afford the defendant their due process.

We still have the rule of law rather than a purely arbitrary rule of men. This case is a terrible situation. A rogue D.A. out to get this guy...The system works right most of the time, law enforcement gets it right, they get the right person... It is a system that doesn't have enough money because we won't fund it...Yet it is still the most magnificent system the world has ever seen."
