#### Last Week Program



**Carl Schwing** came forward to introduce our speaker **Tiffany Esposito**, President and CEO of the Bonita Springs Area Chamber of Commerce

Tiffany has been on the fast track to success all her life. She graduated from Florida Gulf Coast University with a bachelor's degree in communications in 2009 and received a master's degree in business administration in 2012.

She worked for nearly three years at a public relations firm and rocketed through the ranks at the Bonita Chamber from communications manager to director of operations and corporate partnerships to vice president.

In January 2015 she became chief of staff at the Greater Naples Chamber of Commerce, where she directed all the operational, financial and administrative activities of the 1,800-member organization and worked with the board to advance its mission.

"It fit my career path," she said. "I truly love chamber work because it gives me a unique ability to impact the community." She became President and CEO in June 2016, replacing Christine Ross who led the chamber for seven years.

Tiffany said her priorities will include looking at ways to increase workforce housing, improve job creation and partner with universities to find ways to accommodate more job growth and keep more young graduates in the community.

She was born and raised in Lee County, "I think that growth is what allowed me to stay here and grow my career here." But while she's rooted in Lee County, she said she will work with state agencies, the Greater Naples Chamber and other organizations to "move forward as a region."

Another priority will be to attract larger businesses to Bonita Springs while serving the needs of smaller businesses, which she called "the foundation of our community", noting that **if every Chamber member added one job, it would bigger than a Hertz**.

Improvements along the Old U.S. 41 corridor will create a "vibrant downtown, and I hope to assist in that growth," she said.

But Bonita Springs businesses still face challenges, she said — among them seasonal fluctuations that can make it tough to weather the offseason — and she plans to strategize with the board to find ways to create a year-round economy.
